WHEREAS, the Board of Supervisors (“Board”) of the Hacienda North Community Development District (“District”) has previously set the date of the public hearing on the Proposed Budget for Fiscal Year 2021-2022 for September 14, 2022; and

FIRST ORDER OF BUSINESS

Call to Order and Roll Call

Mr. Weyer called the meeting to order and proceeded with the roll call. The members in attendance are as outlined above. He noted that the meeting was advertised according to Florida Statute requirements.

3 Mr. Weyer noted that the Florida Statutes require that there be an opportunity for Public
4 Comment.

6 There were no public comments.

7
8 **THIRD ORDER OF BUSINESS**

10 Mr. Weyer said that there were three public hearings to be considered at this meeting and
11 all three were advertised as such.

12
13 Mr. Weyer requested a vote of the Board of Supervisors to open the public hearing on the
14 District's Rules of Procedure.

15
16 On MOTION by Ms. Aguiar and seconded by Mr. Nadeau, with all in favor, the Board of
17 Supervisors of the Hacienda North Community Development District opened the Public Hearing
18 on the District's Rules of Procedure.

19

21 **A. Consideration of Resolution 2022-34: Adopting the Hacienda North Community**
22 **Development District's Rules of Procedure.**

23
24 Mr. Urbancic explained that these are general rules of procedure that are common with
25 CDDs that provide a framework for the operations of the District such as bidding, etc. and
26 are in the same form that were brought forward at a prior District meeting. He asked that
27 the Board approve the resolution.

28
29 On MOTION by Mr. Nadeau and seconded by Ms. Aguiar, with all in favor, the Board of
30 Supervisors of the Hacienda North Community Development District approved Resolution 2022-
31 34 adopting the District's Rules of Procedure.

32
33 Mr. Weyer requested a vote of the Board of Supervisors to close the public hearing on the
34 District's Rules of Procedure.

35
36 On MOTION by Mr. Nadeau and seconded by Ms. Aguiar, with all in favor, the Board of
37 Supervisors of the Hacienda North Community Development District closed the Public Hearing
38 on the District's Rules of Procedure.

40 Mr. Weyer then provided the affidavit of publication for the District's Rules of Procedure
41 public hearing.

1 **FOURTH ORDER OF BUSINESS**

3 Next, Mr. Weyer requested a vote of the Board of Supervisors to open the public hearing
4 for Resolution 2022-35 that authorizes a capital improvement plan (“CIP”) and provides
5 certain findings that relate to the issuance of assessments that in part fund the CIP.
6

7 On MOTION by Mr. Mulhere and seconded by Mr. Nadeau, with all in favor, the Board of
8 Supervisors of the Hacienda North Community Development District opened the Public Hearing
9 for Resolution 2022-35.

10
11 **A. Consideration of Resolution 2022-35: A Resolution of the Board of**
12 **Supervisors of the Hacienda North Community Development District making**
13 **certain findings; authorizing a capital improvement plan; adopting an**
14 **engineer’s report; equalizing, confirming and levying special assessments;**
15 **addressing the finalization of special assessments; addressing the payment**
16 **of special assessments and the method of collection; providing for the**
17 **allocation of special assessments and true-up payments; addressing**
18 **government property, and making provisions relating to the transfer of real**
19 **property to units of local, state and federal government; authorizing the**
20 **recording of an assessment notice; and providing for severability, conflicts**
21 **and an effective date.**
22

23 Mr. Urbancic said that we essentially started this process at the last meeting with the
24 adoption of the engineer’s report and assessment methodology which are in the same form
25 in this resolution and the Board is sitting as the Equalization Board to the extent that there
26 are any comments or issues with respect to how we laid out the assessments and the
27 adoption of the Capital Improvement Program. He noted that the resolution is in order for
28 the final levy of those assessments. He asked that the Board approve the resolution.
29

30 On MOTION by Ms. Aguiar and seconded by Mr. Nadeau, with all in favor, the Board of
31 Supervisors of the Hacienda North Community Development District approved Resolution 2022-
32 35 authorizing a capital improvement plan (“CIP”) and provides certain findings that relate to the
33 issuance of assessments that in part fund the CIP and levying of the assessments.

34
35 Mr. Weyer requested a vote of the Board of Supervisors to close the public hearing on
36 Resolution 2022-35.
37

38 On MOTION by Mr. Mulhere and seconded by Ms. Aguiar, with all in favor, the Board of
39 Supervisors of the Hacienda North Community Development District closed the Public Hearing
40 on Resolution 2022-35.

41
42 Mr. Weyer then provided the affidavit of publication for the District’s Rules of Procedure
43 public hearing on Resolution 2022-35.

45 Mr. Weyer also provide the affidavit for the Notice of Assessment letter mailing.

1 Next, Mr. Weyer requested a vote of the Board of Supervisors to open the public hearing
2 for Resolution 2022-36 that provides for a uniform method of levying, collecting and
3 enforcing non-ad valorem assessments which may be levied by the Hacienda North
4 Community Development District.
5

6 On MOTION by Mr. Nadeau and seconded by Ms. Aguiar, with all in favor, the Board of
7 Supervisors of the Hacienda North Community Development District opened the Public Hearing
8 for Resolution 2022-36.
9

10 **B. Consideration of Resolution 2022-36: A Resolution of the Board of Supervisors of the**
11 **Hacienda North Community Development District expressing its intent to utilize the**
12 **uniform method of levying, collecting, and enforcing non-ad valorem assessments**
13 **which may levied by the Hacienda North Community Development District in**
14 **accordance with section 197.3632, Florida Statutes; providing a severability clause;**
15 **and providing an effective date.**
16

17 Mr. Urbancic said this is a step the District has to take in order to put our non-ad valorem
18 assessments on the county property tax bill for normal uniform collection and transmittal
19 to the county property appraiser. There was no further discussion.
20

21 On MOTION by Ms. Aguiar and seconded by Mr. Mulhere, with all in favor, the Board of
22 Supervisors of the Hacienda North Community Development District approved Resolution 2022-
23 36 that provides for a uniform method of levying, collecting and enforcing non-ad valorem
24 assessments which may be levied by the Hacienda North Community Development District.
25

26 Mr. Weyer requested a vote of the Board of Supervisors to close the public hearing on
27 Resolution 2022-36.
28

29 On MOTION by Mr. Mulhere and seconded by Ms. Aguiar, with all in favor, the Board of
30 Supervisors of the Hacienda North Community Development District closed the Public Hearing
31 on Resolution 2022-36.
32

33 Mr. Weyer then provided the affidavit of publication for the District's Rules of Procedure
34 public hearing on Resolution 2022-36.

8 On MOTION by Mr. Mulhere and seconded by Mr. Nadeau, with all in favor, the Board of
9 Supervisors of the Hacienda North Community Development District accepted the District's
10 financials through August 2022.
